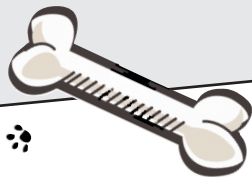
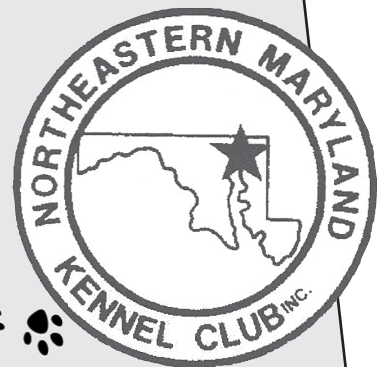

## Notice to Exhibitors

All dogs present must be held on leash or confined to a crate, except when being judged. Judges will not wait for any dog holding up a class.

**Limited grooming area. No dogs may be left unattended on a grooming table for any reason!**

**Absolutely no prong collars allowed on premises. Absolutely no flexi-leads allowed on premises.**

**Day parking only. Lunch will be available for purchase.**

**Professional handlers** may show only dogs owned or co-owned by themselves or members of their immediate families. **Judges and members of their households** will not exhibit, or act as agents or handlers in accordance with Match Show Regulations, Chapter 2, Section 1.

No dog that is a champion of record may be entered in a conformation match (except that champions may be entered in any junior showmanship classes).

No dog with the CDX or equivalent title may compete in any regular class at a sanctioned match except Utility. Such dogs may be entered and participate in the Open B class, but may not compete for any awards in that class.

No dog with the UD or equivalent title may compete in any regular class at a sanctioned match. Dogs with the UD title may be entered and participate in the Open B or Utility classes, but may not compete for any awards in these classes.

For multiple entries of the same dog in Obedience, the score earned in the highest class will be considered for high score in match, and all other classes must be entered FEO.

Match wins carry no AKC championship points, nor do qualifying scores count toward obedience titles.

NEMKC reserves the right to add, or change judges or rings as deemed necessary to expedite the flow of this Match. All AKC show rules and obedience regulations applying to the disqualification of dogs shall apply at sanctioned matches, however, dogs will not be disqualified, but simply excused for the day.

No confirmation for pre-entries will be mailed.

Arm bands will be available for pick up at the Match registration table.
